Form 990, Part III, Line 4a:

Family Promise of Spokane's homelessness prevention programs dramatically increased in the fiscal year as they administered two large housing & rental assistance grants from the City of Spokane as well as several smaller private grants that resulted in serving 605 households (over 1,800 people). Additionally, prior to the fiscal year end they have received noticed of additional funding of \$900,000 from the City of Spokane to continue this program.

Form 990, Part III, Line 4b:

The Emergency Family Shelter program, which included five distinct locations during the fiscal year, sheltered a total of 530 individuals. During the year, we assisted 250 individuals with moving into permanent housing of their own.

Form 990, Part III, Line 4c:

Family Promise of Spokane operates a Stabilization program that works with families that we have helped obtain permanent housing. The program provides assistance with donated household furnishings, assistance with connecting to community resources and overall support to help ensure families are able to continue to meet their obligations to stay in their homes. During the fiscal year, a total of 39 families were served in this program.
